ORDINANCE NO. 3882

AN ORDINANCE AMENDING CHAPTER 19 ENTITLED "GARBAGE AND REFUSE" OF THE TOWNSHIP CODE.

BE IT ORDAINED by the Township Council of the Township of Teaneck, Bergen County, as follows:

SECTION 1. That Chapter 19 be amended with the addition of Article VI, **Improper Disposal of Waste** as follows:

Section 19-46. Definitions:

For the purpose of this ordinance, the following terms, phrases, words, and their derivations shall have the meaning stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

Municipal separate storm water system (MS4). A conveyance or system of conveyances (including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, manmade channels, or storm drains) that is owned or operated by the Township of Teaneck or other public body, and is designed and used for collecting and conveying stormwater.

Person. Any individual, corporation, company, partnership, firm, association, or political subdivision of the State subject to municipal jurisdiction.

Stormwater. Water resulting from precipitation (including rain and snow) that runs off the land's surface, is transmitted to the subsurface, is captured by separate storm sewers or other sewerage or drainage facilities, or is conveyed by snow removal equipment.

Section 19-47. Prohibited Conduct:

The spilling, dumping, or disposal of materials other than stormwater to the municipal separate storm sewer system owned or operated by the Township of Teaneck or other public body is prohibited. The spilling, dumping, or disposal of materials other than stormwater in such a manner as to cause the discharge of pollutants to the municipal separate storm sewer system is also prohibited.

Section 19-48. Exceptions to Prohibition:

- (a) Water line flushing and discharges from potable water sources.
- (b) Air conditioning condensate (excluding contact and non-contact cooling water).
- (c) Irrigation water (including landscape and lawn watering runoff).
- (d) Flows from springs, riparian habitats and wetlands, water reservoir discharges, and diverted stream flows.
- (e) Sidewalk, driveway and street wash water.
- (f) Flows from fire fighting activities.
- (g) Flows from rinsing of equipment used in the application of salt and de-icing materials immediately following salt and de-icing material applications. Prior to rinsing with clean water, all residual salt and de-icing materials must be removed from equipment and vehicles to the maximum extent practicable using dry cleaning methods (e.g. shoveling and sweeping). Recovered materials are to be returned to storage for reuse or properly discarded.

Section 19-49. Enforcement:

The provisions of this Article shall be enforced by the Police Department of the Township of Teaneck.

Section 19-50. Penalties:

Any person violating the provisions hereof, or any part hereof, shall be subject to a fine or penalty as provided in Section 1-6 of the Township Code.

SECTION 2. That all ordinances or parts of ordinances contrary to or inconsistent with this ordinance are hereby superseded.

SECTION 3. That if any section of this ordinance be adjudged invalid or unconstitutional, the same shall not affect the validity of the ordinance as a whole or any other section or provision hereby.

SECTION 4. This ordinance shall take the effect immediately upon passage and publication, or otherwise as provided by law.
